The source is authoritative. If information is not present in the source, it is not represented as fact. Unknown information remains unknown until verified. Missing information is not filled through assumption. Proposed information must be identified as proposed. Existing information must be identified as verified. The examiner must not invent a framework component, relationship, structure, requirement, layer, system, historical claim, or future plan to fill a perceived gap.

If the source and interpretation conflict, the source wins.

2. FRAMEWORK BOUNDARY

10. D DICTIONARY - ENTRY TERMS

PRESENT

The condition of examination as it exists now, before ancestry, explanation, interpretation, or conclusion is introduced. Human action: record what is actually available before explaining it.

SUBJECT

The thing, condition, event, information, claim, relationship, process, system, phenomenon, object, or other identifiable matter encountered within PRESENT. Human action: identify it precisely.

TARGET

The precise portion, property, condition, question, relationship, claim, behavior, or feature of the SUBJECT toward which examination is directed. Human action: narrow the examination without silently changing the subject.

LOCATION / CONTEXT

The position and surrounding conditions within which the TARGET exists or has meaning. Context may be physical, informational, temporal, relational, organizational, mathematical, digital, conceptual, jurisdictional, or otherwise appropriate.

SOURCE

The immediate recoverable point from which the TARGET, information concerning it, or the examined condition was obtained, produced, transmitted, observed, recorded, encountered, or derived.

SOURCE ANCESTRY

The recoverable succession behind SOURCE: preceding sources, transmissions, transformations, records, dependencies, materials, conditions, causes, or antecedents. The immediate source is not presumed to be the origin.

CREATION / CAUSE
